Investigation revealed the following. Christopher Carpenter (w/m, 08/25/1947), here-after referred to as the defendant, was at the Ft. McCoy Public Library near the intersection of County Roads 315 and 316. He was advised by an unknown individual that his dog was attacked at the defendant's residence by dogs belonging to his neighbor, victim Shawn Willmot (w/m, 04/30/1970). The defendant drove to the area of the incident location of the victim's residence. The dogs were separated and secured prior to the defendant's arrival. The defendant walked to the incident location, across the street from his residence, located at 14894 Northeast 110th Court Road to confront the victim about the dogs. The defendant confronted the victim on the victim's property just outside the victim's front door. The defendant's son, eye-witness was standing nearby and the defendant's wife, reportee was inside the incident location. A short verbal altercation ensues regarding the dogs fighting. The victim told the defendant to leave the property. The defendant pulled out a pistol and fired multiple shots at the victim, striking him three (3) times, once in the face, in the wrist, and in the forearm. The victim fled into his residence, velling to that he had been shot. If the fled on foot away from the defendant. The defendant fled the area with his injured dog. He drove to the Ft. McCoy Library, where he called 911 and advised the call-taker, he had just shot the victim. The victim was not able to be interviewed due to being flown by medivac helicopter to UF Health Shands hospital for immediate medical treatment. Interviews with multiple neighbors and witnesses, and and confirmed this account of the inciden 💬 Three 9mm Rell casings were located at the incident location, consistent with witness testimony. A 9mm bistol was surrendered to law enforcement by the defendant, at the library. The defendant was transported by MCFR for medical evaluation. He was read Miranda warnings and invoked his right to counsel. Based on the aforementioned facts, witness statements, and spontaneous utterance by the defendant during his 911 call, probable cause exists for the arrest of the defendant for attempted homicide.
