**PROBABLE CAUSE**

THE UNDERSIGNED CERTIFIES AND SWEARS THAT THERE IS PROBABLE CAUSE TO BELIEVE THE ABOVE-NAMED DEFENDANT, WHO WAS POSITIVELY IDENTIFIED BY FLORIDA DRIVERS LICENSE ON THE 23 DAY OF MAY 2018 , AT APPROXIMATELY 2:33 [X] A.M. [ ] P.M. AT 2431 US 1 S (MCDONALDS) WITHIN ST. JOHNS COUNTY, VIOLATED THE LAW AND DID THEN AND THERE:

- 1.) 784.021.1a - AGGRAVATED ASSAULT WITH A WEAPON
- 2.) 810.02.2a - BURGLARY WITH ASSAULT/BATTERY
- 3.) 810.08.2c - ARMED BURGLARY

On May 23, 2018, I responded to 2431 US 1 S (Mcdonalds) in reference to a disturbance.

The defendant (John Smith) was in a verbal altercation with the victims (Mohamed Galal, Zeyad Said) to which he pulled a knife which put the victims in fear and they retreated back into their vehicle. The victims advised while the defendant was yelling at them he stated "get out of my Country you do not deserve to eat here"! The defendant then went back into his vehicle and grabbed an electrical stun gun. The defendant approached the vehicle while the victims were inside to get away from the defendant.

The defendant then put his arm in the driver side back seat window in attempts to shock, Zeyad Said. The defendant then stuck his arm in the driver side window in attempts to shock Mohamed Galal to which Mohammed had to lean back further into the vehicle to avoided getting shocked in the face by the stun gun. While Mohamed was trying to flee from the defendant, Mohamed backed into a pole in the parking lot causing minor damage to the rear left rear bumper of the vehicle.

Based on the physical the evidence, the victims and witness statements probable cause was established for Aggravated Assault with a weapon, Burglary with assault/battery, and armed burglary. The statements made by the defendant to the victims showed that he [the defendant] only committed the acts due to the victim's religion. While in the back seat of my patrol vehicle, the defendant continued to say "they killed my son." "my son was a Marine".

The defendant was then transported to the St. Johns County Jail without further incident.



Mohamed turned the car on and the guy kept sticking his hand in through the window with the taser on. as we were backing out we hit ~~the~~ a pole as we were nervous and during all that the guy continued to shout and use the taser. we left to the road (US 1) and I called 911 immediately.



defendant was yelling at them he stated "get out of my Country you do not deserve to eat here"! The defendant then went back into his vehicle and grabbed an electrical stun gun. The defendant approached the vehicle while the victims were inside to get away from the defendant.

The defendant then put his arm in the driver side back seat window in attempts to shock, Zeyad Said. The defendant then stuck his arm in the driver side window in attempts to shock Mohamed Galal to which Mohammed had to lean back further into the vehicle to avoided getting shocked in the face by the stun gun. While Mohamed was trying to flee from the defendant, Mohamed backed into a pole in the parking lot causing minor damage to the rear left rear bumper of the vehicle.

Based on the physical the evidence, the victims and witness statements probable cause was established for Aggravated Assault with a weapon, Burglary with assault/battery, and armed burglary. The statements made by the defendant to the victims showed that he [the defendant] only committed the acts due to the victim's religion. While in the back seat of my patrol vehicle, the defendant continued to say "they killed my son." "my son was a Marine".

The defendant was then transported to the St. Johns County Jail without further incident.

On May 23, 2018, I responded to 2431 US 1 S (Mcdonalds) in reference to a disturbance.

Upon arrival I made contact with John Smith. John had the smell of an alcoholic beverage emitting from his person and he was slurring his words. John made spontaneous statements advising "I am American and the guys by the vehicles were making ruckus so I told them to get out of here and one of them pulled a gun and they left in a red vehicle". While on scene the red vehicle which was a 2006 red Nissan bearing Florida tag JTKV23 arrived back on scene along with a gray 2001 Mitsubishi bearing Florida tag IHGF32.

I then conducted a recorded statement with John who advised post Miranda, He parked and he saw rowdiness next to the subject's vehicles, he then called his wife. John then advised the subjects were saying things to him so he exited his truck. John advised he then heard one of the guys say let's get out of the vehicle to which John stated "that wouldn't be a good idea". John advised he then had his "zapper" (electrical stun gun) in his pocket. John advised he then put his "zapper" by their window and initiated a shock with it. It should be noted during the recorded statement John never advised of a gun being pulled on his person.

Zeyad Said advised him and Gasser Elkady, Mohamed Gala, and Omar Abdelmoaty, were standing at the back of their vehicles when John was standing at the rear of his 2006 black Ford bearing Florida tag Y40FDJ. Zeyad advised John was on his phone standing by his truck yelling "Get out of my Country you need to leave" while holding an automatic pocket knife in his right hand. Zeyad advised him and his friends went into the vehicles to which John went back to his vehicle and retrieved an electrical stun gun and approached the vehicle Zeyad was in. Zeyad advised he was sitting in the driver side back seat of the red Nissan when John reached in with his arm and tried to shock him with the electrical stun gun.

Mohamed Gala advised he was standing near the vehicle eating food with his friends. He observed John on the phone and was yelling at him and his friends with a pocket knife in his hands. He kept asking his friends if they were "American Boys". Mohamed advised he also made comments stating "get the fuck out of here you don't deserve American food". Mohamed and his friends went into the vehicles to get away. Mohamed advised they were then approached by John with the electrical stun gun. Mohamed advised John stuck the stun gun in the driver back

seat to attempt to shock his friend. Mohamed was sitting in the driver's seat and John stuck his arm in his window to which the stun gun was shocking so close he had to sit back to avoid it from shocking his face. Mohamed then backed his vehicle up in attempts to flee from John which caused him to hit a pole in the parking lot causing minor damage to the rear left bumper.

Alaina Doyle who is the manager at McDonalds advised she observed John exit his vehicle and advance towards Mohamed's vehicle with the electrical stun gun. Alaina advised she observed John reach into Mohamed's vehicle with the electrical stun gun and attempting to shock the occupants inside the vehicle.

I placed John in my custody and secured him in the back of my patrol vehicle. John then complained of shortness of breath to which I had Fire Rescue (RUN#18-0016591) respond and evaluate John. Affidavits were collected from parties involved. Deputy Milillo (3773) took photographs of the scene and submitted the audio statement from John and submitted the knife which was on John into evidence. John was placed under arrest for the listed charges and transported to the St. Johns County Jail without further incident.

On 5/23/18 I responded to 2431 US Highway 1 South(McDonalds) in reference to a disturbance complaint. I was in the immediate area, and arrived on scene while SJSO Communications was still obtaining information. Upon my arrival, I made contact with John Smith.

John stated he was just involved in a verbal confrontation with multiple subjects. Furthermore, John stated the altercation was allegedly unprovoked and he was unsure why the subjects were confronting him. A brief time later, two vehicles entered the parking lot and stated they were involved in the altercation with John.

I then spoke with Omar Abdelmoaty. Omar stated he and his friends were standing in the parking lot and eating some food when they observed John exit his truck. Omar advised John stood at the rear of his truck while having a phone conversation. According to Omar, John then began to raise his voice and became confrontational with him and his friends. At this time, John removed a knife and an electrical stun gun from his pockets. John brandished the weapons and began to advance towards Omar and his friends. Omar was able to describe the knife as a switch blade style, automatic knife, with a black handle and gray colored blade.

After speaking with Omar, I made contact with the McDonald's manager, Alaina Doyle, in reference to possibly obtaining surveillance video. Alaina stated she was unable to recover the video, but stated she witnessed some of the incident. Alaina advised she witnessed John exit his vehicle and approach the victims with the electric stun gun. Additionally, she stated John reached inside the vehicle while threatening the victims with the stun gun. Alaina provided a sworn written statement about the incident.

I then interviewed Mohamed Gala. Mohamed stated he was standing at the rear of his vehicle when the altercation began. As John began to approach him with the weapons, he retreated to his vehicle for safety. However, his driver's side window was down and John was able to reach inside the vehicle. Mohamed then described how the electric stun gun was very close to his face as he attempted to flee the scene in his vehicle. This was so disturbing to Mohamed, he backed his vehicle into a concrete pole in the parking lot. I then observed paint transfer from Mohamed's vehicle on the concrete pole.

While assisting Deputy Pamies with her portion of the investigation, I heard John make the spontaneous utterance of "they killed my son." John went on to ramble about how his son died in Afghanistan while in combat with the Marine Corp. These statements were made without any input or conversation from this deputy.

During my portion of this investigation, I collected a black automatic knife for evidence purposes. This knife was located on John's person. I also captured photographs of the scene and the victims. As I captured photographs, I discovered all the McDonalds food on the ground in the parking lot was the food that was being consumed by Omar and his friends, prior to the incident. All evidence collected was placed into the SJSO Evidence Facility.
