On July 11th, 2018, at approximately 1911 hours, in Stuart, Martin County, Florida, Geoffrey Ian Mckelvey did unlawfully expose his sexual organs, at the business of Target Department Store located at 2650 NW Federal Highway. Upon further investigation Mckelvey was also found to be in violation of Florida State Statues 893.13(6a) 893.13(6b) and 893.147.

On July 11, 2018, at approximately 1930 hours, units responded to 22650 NW Federal Highway in reference to a past Lewd and lascivious complaint. Upon arrival units made contact with the store Manager William, who stated the following.

William stated that an unknown white male approximately 50's to 60's years of age, entered the store wearing a grey shirt and dark shorts with flip flops. Williams further stated the male was observed by customers and CCTV Surveillance dropping his pants and exposing his genitals. The Unknown male was also observed knocking items off the self.

A search of the nearby area was conducted and a white male matching the description was located at the residence 2321 Bay Colony Court. The male was later identified through his Florida driver's license as Geoffrey Ian McKelvey. Contact was made with Mckelvey inside of the residence where Mckelvey was questioned in reference to the incident that occurred at Target. Mckelvey stated that he was told by his teachers to go to Target and destroy items inside of the store. Mckelvey further stated while in the store he was approached by someone and as result of being confronted he dropped his pants and told the person to kiss his ass.

While inside of the residence speaking to Mckelvey a strong odor of fresh cannabis was detected and in several locations cannabis was observed in plain view.

Mckelvey willing consented to a consent to search of his residence. The reading of the consent to search form was read, recorded and explained in detail to Mckelvey.

During the search of the residence the following items were located.

Shoe box containing approximately 5.0 grams of cannabis.

5 clear plastic bags that contained traces of white powdery substance.

11 Glass smoking pipes with THC Resin.

Clear plastic bags containing cannabis weighing approx. 1.2 grams.

Post Miranda Mckelvey stated that two other people also reside in the residence with him but all of the items located inside of the residence was blessed to him by god and that they belonged to him.

Based on my investigation Geoffrey Mckelvey was placed under arrest for exposure of sexual organs, Possession of drug paraphernalia, Possession of Cannabis under 20 grams, and possession of THC Resin.

Upon arrival the Martin County Jail, the booking nurse requested that Mckelvey be transported to ER South for a medical clearance.

Mckelvey was transported to ER South where a medical assessment was completed. Mckelvey was cleared and was
