The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:  
 The defendant and victim became involved in a political argument via the social media website Facebook. On today's date after receiving several explicit messages and threats the defendant responded to the victim's home to confront him reference the messages. The defendant anticipating the confrontation would escalate brought his AR-15 Carbine and a compact Glock semi-automatic pistol. Upon arrival to the victim's residence (3002 Wallace Av. W.) the defendant honked his horn and waited by his truck for the victim to exit the home. The victim exited the home and immediately charged/sprinted towards the defendant who drew the Glock pistol from an outside the waistband holster and fired 2 shots at the victim striking him in the right thigh and buttocks. The victim ran away and the defendant fled the scene. The victim identified the defendant as the shooter via name. The defendant later contacted the police to "turn himself in". The defendant post-miranda admitted to the offense. The defendant does not currently poses a concealed weapons permit.

The defendant was ID' via FL DL.
