[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On July 29, 2018 I responded to 7720 Deaton Bridge Road reference a disturbance. Dispatch advised a subject fired a gun during a verbal disturbance and left the scene. The suspect vehicle was described as a silver Kia with Alabama license plate.

Up arrival in the area of 7720 Deaton Bridge Road all responding units made contact with the suspect vehicle and initiated a felony traffic stop. Once all vehicle occupants were detained and secured, I made contact with the complainant, who provided the following account of events:

The complainant was at Blackwater River State Park with family when the suspect, Tyson Lee Miller, confronted the complainant about throwing a cigarette in the sand. Miller approached the complainant in an aggressive manner and the complainant told Miller to back off. The complainant stated Miller then walked to his camp site, reached into a bag, and pulled out a handgun. Miller motioned toward the complainant in an aggressive, threatening manner with the handgun in his hand. The complainant stated Miller said "what now", or "what are you going to do now", and then fired one shot. The complainant stated he feared for his life when he saw the gun. After Miller fired the gun, he placed it back in the bag. Miller then pulled out a large knife and made threatening gestures with it, as he did with the gun. The complainant found these gestures threatening and feared for his life. The complainant stated he thought Miller was going

to shoot and kill him. When Miller put the gun away, and grabbed the knife, the Complainant thought Miller was going to stab him.

I read Miller his Miranda warning and he agreed to speak to me. I asked Miller to walk me through what happened, and Miller provided the following account of events: Miller stated he took issue with the complainant throwing his cigarette on the ground and said something to him about it. Miller stated the complainant got animated and started cussing him out. Miller stated another woman joined in and started cussing at him, and his wife. Miller said his wife reached in his bag, pulled out his gun, and handed it to him. Miller said he "fired one shot into the ground to deescalate the situation." Miller denied brandishing the gun or using it in a threatening manner. Miller also denied using his knife to threaten or intimidate the complainant. While being transported to the jail, Miller told me he knew firing his gun was a bad idea and he asked me how long he would be in prison.

Based on evidence collected and statements from the complainant and multiple witnesses, I placed Miller under arrest for violation of Florida Statute 784.021.1a - aggravated assault with a deadly weapon without intent to kill (2 counts) and 790.15.1 firing weapon in public or residential property. Miller was transported to the Santa Rosa County Jail without incident and given a total bond of \$10500.

This arrest occurred in Santa Rosa County, Florida.
