asked him what happened and if he was okay. The male (later identified by his Flagler County booking photo as Corey Hatzl) kept yelling "look at my dick, look at my ass". Hatzl was yelling comments that were not pertaining to my questions and unintelligible things.

I made contact with Mabini and her friend Donald Ellis. Ellis was the male that Hatzl was yelling at when I arrived. Mabini stated that her boyfriend called her when she was leaving work telling her that he was riding his bike by Winn Dixie, when Hatzl started chasing him on foot. Mabini stated that she and Ellis arrived at Chick Fil A and found Hatzl trying to fight her boyfriend. Mabini stated Hatzl took off his clothes and she told her boyfriend to leave, so he did not get into a fight with Hatzl. Mabini state that Hatzl kept yelling "you're gay for looking at my penis". Ellis stated that male was bleeding from his face and yelling at him.

I asked if they wanted to press charges for indecent exposure and they both stated no. A medical unit arrived to check out the male and stated that they did not have any reason to transport the Hatzl. While trying to get Hatzl to put on his shorts he kept yelling "look at my dick". I observed multiple vehicles drive by while Hatzl was nude and "yelling look at my dick".

We asked Hatzl his name multiple times and he said Corey and then a non-understandable last name. I asked Hatzl how to spell his name and he would not tell me. Cpl. Barile moved Hatzl's handcuffs to the front and tried to use his Rapid ID, to identify the male. Hatzl pulled his hands away and then jerked his arms away from Dep. Ocampo. At one point Hatzl used his elbow to push Dep. Ocampo's arm away from gripping his shoulder telling him to let go. At that time we moved Hatzl to his knees and re-secured his hands behind his back.

Hatzl was placed under arrest for obstruction resisting without violence, and breach of peace disorderly conduct. I transported Hatzl to Florida Hospital Flagler (FHF) where he refused medical treatment and was medically cleared. I transported Hatzl to the FCIF without incident.

While I was sitting in the sally port, I was able to get Hatzl to spell out his last name, and then I confirmed his identification by his FCIF booking photograph.

I contacted both Mabini and Ellis by phone and they reaffirmed, that they did not want to sign charges for indecent exposure.

I charged Hatzl with breach of peace; for running around the public areas nude and yelling and swearing in a public area where Mabini, Ellis, other people heard and saw it. Hatzl was charged with obstruction; for
