PROBABLE CAUSE AFFIDAVIT:

Before Me, the undersigned authority personally appeared Patrol Officer Christopher Villafane who being duly sworn, alleges, on information and belief, that on the 5th day of February, 2019, in Lake County, Florida, the defendant did:

commit; F.S.S. 812.014 (3C) Petit Theft (3rd Conviction)

On 02/05/2019 at approximately 2157 hours, I, Officer Villafane M35 responded to the area of 441 East Myers Boulevard (the Dollar General) in reference to a theft that just occurred.

I made contact with Cameron Mccutcheon (store manager) who stated she observed a black male in a brown or orange hoodie and backpack enter the store and steal items out of the food aisle. I asked if she observed what he took and she stated popartars. I observed the video which showed the subject enter the store. The suspect did not pay for the items and left the store passing all points of sale. Cameron completed a sworn statement and signed a intent to prosecute. Cameron provided Law Enforcement with survalience video which shows the suspect taking the items. I immediately started to canvass the area.

At approximately 2217 hours, I observed the suspect sitting at 11 East Myers Boulevard. The suspect, identified as Timothy Jerome Kinsy (the defendant) matched the suspect in the survalience video. The defendant was detained at this time and read his miranda rights. Post miranda, the defendant denied being in the store. I asked him again and the defendant stated he was in the store and he was hungry. I asked the defedant what was taken and he stated the Cinnamon Toast Crunch and Poptarts. The defendant was placed under arrest at this time. I conducted a search of the bag and located Cinnamon Toast Crunch (\$1.00) and Clover Valley Cherry Poptarts (\$1.00) inside of the bag. These items were placed in evidence. The defendant was transported to the Mascotte Police Station for booking.

A criminal history was run on the defendant and showed 3 prior convictions. The defendant was then transported to the jail in Tavares, Florida.
