ARRESTED CO-DEFENDANTS

DEFENDANT DID THE FOLLOWING ACT(S) WHICH CONSTITUTE A VIOLACTION OF THE LAW (ELEMENTS OF THE CRIME/PROBABLE CAUSE STATEMENT

On Sunday April 7, 2019 at 1529 hours Police Officers Kazmierczak #293 and Travis #235 responded to the Olive Garden Restaurant, located at 1565 5Th Avenue South in reference to an intoxicated male causing a disturbance. Upon arrival the Officers observed a white male, later identified by his Florida ID Card as Ben Padgett, sitting on a bench to the right of the front door.

Both Officers Kazmierczak and Travis then exited their marked NPD patrol vehicle and they approached Padgett who was not wearing a shirt and was shoveling spaghetti into his mouth using his hands. As the Officers got closer they detected a strong smell of an alcoholic beverage emanating from Padgett who then began to yell obscenities in their direction. Officer Kazmierczak then attempted to speak with Padgett as Officer Travis met with Ronald Worst who unlocked the front door to the Olive Garden and came outside.

Worst then explained to Officer Travis that customers informed him that a white male, Padgett, who was not wearing a shirt was standing outside the front door asking patrons for money. Worst then added that when he approached Padgett and asked him to stop asking the patrons for money Padgett stated "Where is the guy who said that so I can beat his ass." Worst further stated at that point he told Padgett he was calling the police but Padgett stated that "I could beat your ass!". Worst then explained that he left Padgett outside and entered the restaurant to call the police but Padgett followed him inside and repeatedly stated, in a loud voice in the presence of restaurant patrons, "Do you have a Dick or a Vagina?" Worst then informed Officer Travis that Padgett then repeatedly entered and exited the restaurant yelling various expletives while he was on the phone with a Naples Police dispatcher. Worst then stated that after Padgett went outside and sat down on the bench and began eating food, with his hands, he locked the front door of the business to prevent Padgett from coming back inside. Worst also stated that Padgett, who smelled like he had been drinking alcohol, created a disturbance in the restaurant which alarmed and annoved the quests and patrons

Worst then provided Officer Gullekson #225 with a signed sworn statement indicating that he would assist in prosecuting Padgett.

Officer Travis returned to Officer Kazmierczak who had been attempting to speak with Padgett. Officer Travis then informed Padgett, who was still muttering obscenities, that he was being placed under arrest for Disorderly Intoxication. The Officers then had Padgett stand and they assisted him by using paper towels to wipe his face and hands from the debris of eating the food. Then without incident Padgett was placed in handcuffs but when Officers Travis and Kazmierczak began to place him in the rear of their patrol vehicle he began to violently twist his body and kick his legs. Then with assistance from Officer Gullekson the three Officers where finally able to get Padgett into the rear seat of the patrol vehicle. Officer Kazmierczak then made sure that Padgett was seated correctly and that his seatbelt was fastened.

Officer Travis then entered the patrol vehicle, #4050, and as he began move the vehicle from in front of the entrance of the Olive Garden Padgett began to smash his forehead on the medal cage of the partition. Officer Travis observed that Padgett had injured himself and that his forehead was bleeding heavily. Officer Travis immediately advised Naples Police Dispatch of Padgett's injury and Collier County EMS was dispatched to the scene. Due to his agitated state, Officer Travis and Kazmierczak transported Padgett to the Naples Jail Center and

requested that EMS respond to that location. Padgett, during the ride to NJC, continued to bang his head on the medal cage partition.

Upon arrival at the Naples Jail Center Collier County EMS Medic #20 and Collier County Sheriff's Office Jail personnel assisted the Officers in safely removing Padgett from the patrol vehicle and placed him safely on the EMS stretcher. Collier County EMS Medic #20 then transported Padgett to Naples Community Hospital for treatment (Run#19030280).

Once at Naples Community Hospital Officer Travis and Kazmierczak explained to Padgett that he was under arrest and that he was being charged with Disorderly Intoxication and Resisting an Officer Without Violence. The officers explained to Padgett that after he is treated for his injuries he would be transported to the Naples Jail Center for the booking process.

Officer Travis took digital photographs of the rear of NPD vehicle #4050 and off Padgett. These photographs along with the in-car video were entered into NPD Property as evidence. A request for a copy of the 911 call made by Ronald Worst was submitted to NPD dispatch and when it is produced it will be entered into NPD Property as evidence.
