## SUMMARY OF OFFENSES AND PROBABLE CAUSE AFFIDAVIT

The above named defendant was arrested for the following reasons:

On June 6th of 2019 at 1959 hours, I responded to a civil matter call, at 4817 SE Salerno Road, The Manatee Island Grill. Upon arrival, I made contact with the manager of the establishment, Mr. Aaron Hoilman whom advised a female has refused to pay her tab at the bar. Mr. Hoilman stated he advised the female if she could call someone to pay for the tab, or come to some solution. Mr. Hoilman stated the female would not make any statements. I observed the female, as Mr. Hoilman pointed her out to me. Mr. Hoilman stated he wanted to press charges since she refused to pay. Upon entering the restaurant, I observed the female quickly run into the males restroom, then the womens restroom. The female was in the womens restroom for approximately ten minutes, my partner, Deputy Vanessa Ambroise entered the womans restroom to ensure she was okay. I observe Deputy Ambroise exit the restroom, with the female on her own free will.

I made contact with the female, whom had low eye lids, bloodshot glassy eyes, poor balance, emitted the odor of both an alcoholic beverage from her mouth, and displayed a large wet spot on her pants which smelt of urine. I introduced myself to the female, as Deputy Bravo from the Martin County Sheriff's Office. I advised the female the restaurant would like her to pay her bill, the female stated "I didn't bring any money for the stuff I had." I advised the female she would be stealing if she refused to pay, and she stated "No, I'm not stealing. I just don't feel like I should have to pay for it, ya know." I advised the female, the restaurant will accept a payment over the phone if she could contact a friend, and she replied "Well I can't do that really." The female continued to stare at her phone. I asked the female what is her name, and she begun to walk away, and towards Mr. Hoilman. I asked the female if she could stop walking away, and advise me of her name, but she continued to walk towards Mr. Hoilman. I told the female to stop walking away, and give me her name, but she disobeyed the orders. The female was preventing me, from conducting my investigation, as she refused to cooperate. The female was uttering an indiscernible statement at Mr. Hoilman when she was stumbling towards him, and refused to listen to my commands. I attempted to grab the females arm to prevent her from harming Mr. Hoilman, and continuing the investigation. The female resisted my grip, pulled her arm forward, continuing towards Mr. Hoilman, and away from me. I placed the female in a shoulder lock, while Deputy Ambroise attempted to restrain her in handcuffs. I stated "Stop resisting, and calm down!" to the female, as she continued to jerk her body away from deputies. The female was eventually restrained in handcuffs after a brief struggle. The female had to be assisted in walking to the patrol vehicle, and sitting in the patrol vehicle. The female repeatedly screamed "I did not do anything!" The female identified herself as, Ms. Melissa Brown. Ms. Brown's bill was \$30.36 total. Ms. Brown's bill consisted of three Ketel one drinks costing \$19.50, one pepperoni pizza costing \$9.00, and \$1.86 in sales tax.

Ms. Brown was arrested for defrauding an innkeeper, resisting without violence, and transported to the Martin County Jail. Mr.

The above named defendant was arrested for the following reasons:


Hoilman completed a written statement. A copy of the receipt will be submitted into records at the Martin County Sheriff's Office.
