On 06/13/2019 defendant was stopped roadside at approximately 01:25am on his bicycle as a suspicious person. Defendant had with him, a white garbage bag full of what he identified as deflated pool floats. In the past 7 months, the city of Palm Bay has been plagued with burglaries in which the suspect cuts the screen or otherwise enters a victim's back pool deck area and steals only pool floats. There have been an estimated 13 reports made in this time frame. Multiple victims indicated that they had been burglarized several times by this person but only reported in on the second or third burglary of their floats.

Defendant was read his Miranda warnings and agreed to speak with me without an attorney. Defendant stated essentially the following about this case: that he went into the back-yard pool area because he was able to see the floats from the road. Defendant said that he has stolen several pool floats from multiple locations and would occasionally have to cut the screen to gain entry. In this case, the screen was cut (\$50 damage). Defendant drove officers to the vacant house in which the defendant kept the floats. Approximately 75 pool floats were located here including ones that this victim described, white long float and one long blue float. Defendant stated that he sexually gratifies himself with the pool floats instead of raping women.

Victim in this case wishes to pursue charges and stated that she has been burglarized on two separate occasions in which her pool floats were stolen but only called in this report which was reported on 06/06/2019. She stated that her screen was cut to open the lock which she had locked the night previous.
