Before Me, the undersigned authority personally appeared _____ who being duly sworn alleges, on information and belief, that on the 17TH day of MARCH, 2017 in LAKE County, Florida, the defendant did:

COMMIT THE OFFENSE AGGRAVATED ASSAULT WITH A FIREARM- HATE CRIME TO WIT:

ON 3/17/2019 I RESPONDED TO 10641 GOOSE PRAIRIE RD IN LEESBURG, FLORIDA IN REFERENCE TO AN AGGRAVATED ASSAULT COMPLAINT.

WHILE ENROUTE I WAS ADVISED THAT JUVENILE VICTIMS 1 AND 2 WERE WALKING HOME FROM THE BP GAS STATION WHEN THEY WERE CONFRONTED BY 2 WHITE MALES LATER IDENTIFIED AS ARRESTEE 1 JAMES REIDNAUER AND ARRESTEE 2 BRENT VAN BESIEEN. DURING THIS CONFRONTATION BOTH ARRESTEES FIRED A SHOT AT THE JUVENILE VICTIMS AT WHICH TIME BOTH JUVENILE VICTIMS FLED TO THEIR RESIDENCE AND THE COMPLAINANT CALLED 911 FOR ASSISTANCE.

UPON ARRIVAL I MADE CONTACT WITH MS. MICHELLE SABB, THE COMPLAINANT HER CHILDREN, JUVENILE VICTIMS 1 AND 2. JUVENILE VICTIM 1 IS A 16 YEAR OLD MALE AND JUVENILE VICTIM 2 IS A 12 YEAR OLD FEMALE. UPON SPEAKING WITH THE COMPLAINANT SHE ADVISED ME THAT HER CHILDREN HAD WALKED TO THE NEARBY CONVENIENCE STORE AND A SHORT TIME LATER THEY QUICKLY ENTERED THE RESIDENCE AND ADVISED HER THAT THEY HAD BEEN CONFRONTED BY 2 WHITE MALES AS THEY WERE WALKING HOME AND THE WHITE MALES SHOT AT THEM.

I THEN SPOKE TO JUVENILE VICTIM 1 AND HE ADVISED ME THAT HE HAD WALKED TO THE STORE WITH HIS SISTER JUVENILE VICTIM 2 AND WHEN THEY WERE RETURNING HOME THEY WERE USING A SHORTCUT THROUGH A PEICE OF PROPERTY OWNED BY A NEARBY CHURCH THAT THEY USE EVERYDAY TO GO TO THE STORE OR CATCH THE BUS. HE FURTHER STATED THAT AS THEY WERE WALKING ALONG THEY WERE CONFRONTED BY TWO WHITE MEN WHO ASKED WHAT THEY WERE DOING AND HE ADVISED THEM THAT HE WAS JUST WALKING HOME WITH HIS SISTER WHEN ARRESTEE REIDNAUER FIRED ONE SHOT FROM A HANDGUN INTO THE GROUND NEAR WHERE HE AND HIS SISTER WERE STANDING. JUVENILE VICTIM 1 THEN STATED THAT HE ASKED ARRESTEE REIDNAUER " WHAT ARE YOU DOING?" AT WHICH TIME ARRESTEE VAN BESIEEN CALLED HIM A "NIGGER FUCKBOY" AND FIRED ONE ROUND FROM A SHOTGUN NEAR WHERE HE AND JUVENILE VICTIM 2 WERE STANDING.

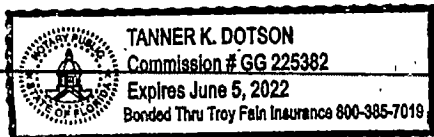

 Before Me, the undersigned authority personally appeared _____ who being duly sworn alleges, on information and belief, that on the 17TH day of MARCH, 2017, in LAKE County, Florida, the defendant did

JUVENILE VICTIM 1 THEN STATED THAT HE TOLD HIS SISTER TO RUN AND CALL 911 AT WHICH TIME THEY FLED ON FOOT BACK TO THEIR RESIDENCE AND AS THEY WERE RUNNING ARRESTEE REIDNAUER YELLED " GET OUT OF HERE NIGGERS."

I THEN SPOKE TO JUVENILE VICTIM 2 WHO PROVIDED AN IDENTICAL ACCOUNT OF THE INCIDENT AS TOLD BY JUVENILE VICTIM 1. I THEN OBTAINED SWORN STATEMENTS FROM BOTH JUVENILE VICTIMS, THE COMPLAINANT INDICATED HER INTENT TO PROSECUTE ON THEIR BEHALF AND SHE WAS ISSUED A VICTIMS RIGHTS PAMPHLET. NEITHER JUVENILE VICTIM SUFFERED ANY PHYSICAL INJURY FROM THIS INCIDENT BUT BOTH WERE VERY VISIBLY FRIGHTENED. I SHOULD NOTE THAT BOTH JUVENILE VICTIMS ARE OF CAUCASIAN AND AFRICAN AMERICAN HERITAGE.

WHILE I WAS INTERVIEWING THE JUVENILE VICTIMS, M/D FITZGERALD HAD LOCATED BOTH ARRESTEES IN THE AREA OF 10551 GOOSE PRAIRIE RD, I THEN RESPONDED TO THAT LOCATION AND UPON ARRIVAL BOTH ARRESTEES WERE READ MIRANDA FROM A PREPRINTED CARD AND BOTH STATED THEY UNDERSTOOD THEIR RIGHTS AND AGREED TO SPEAK WITH ME.

I THEN ASKED ARRESTEE REIDNAUER WHAT HAD OCCURRED AND HE STATED THAT HE OBSERVED TWO METH HEADS WALKING THROUGH THE AREA AND HE STOPPED THEM TO SEE WHAT THEY WERE DOING BECAUSE THEY WERE NEAR A RESIDENCE. HE FURTHER STATED BECAUSE THEY WERE ACTING SUSPICIOUSLY HE FIRED A WARNING SHOT AT THEM. HE DESCRIBED THE PEOPLE HE SAW AS A "BROWN GUY" AND A ^{several} WHITE GIRL IN THERE 20'S OR 30'S. ARRESTEE REIDNAUER ALSO WAS OPENLY CARRYING A ~~SHOTGUN~~ HANDGUN ON HIS RIGHT SIDE. I THEN ASKED HIM IF THERE WAS A SHOTGUN INVOLVED AS WELL AND HE ADVISED ME THAT THERE HAD NOT BEEN ONE USED ONLY HIS HANDGUN.

I THEN ASKED ARRESTEE VAN BESSEN WHAT HAD OCCURRED AND HE STATED THAT HE AND ARRESTEE REIDNAUER HAD CONFRONTED 2 METH HEADS AND ARRESTEE REIDNAUER FIRED A WARNING SHOT INTO THE GROUND TO PREVENT THEM FROM BREAKING INTO A HOUSE. HE ALSO DESCRIBED THEM AS A BLACK OR BROWN GUY AND A WHITE GIRL. HE ALSO DENIED EVER BEING ARMED WITH A SHOTGUN OR FIRING A SHOT. WHILE SPEAKING WITH HIM HE THEN CHANGED HIS STORY SAYING HE NEVER ACTUALLY GOT A GOOD LOOK AT THE PEOPLE BECAUSE HE WAS QUITE A DISTANCE AWAY FROM ARRESTEE REIDNAUER WHO WAS MUCH CLOSER TO THE JUVENILE ARRESTEE'S THAN HE WAS. BOTH ARRESTEE'S ALSO DENIED USING ANY RACIAL SLURS.

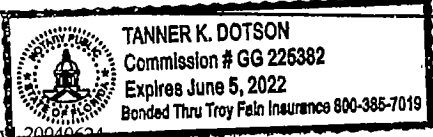

THE RECOVERED SHELL CASING WAS THE SAME BRAND AS THE ROUNDS IN THE SMITH AND WESSON 9MM HANDGUN THAT ARRESTEE REIDNAUER HAD IN HIS POSSESSION.

AT THIS TIME BASED ON THE STATEMENTS OF ALL PARTIES INVOLVED BOTH ARRESTEES WERE PLACED UNDER ARREST AND TRANSPORTED TO THE LAKE COUNTY JAIL WITHOUT FURTHER INCIDENT. THE SPENT SHELL CASING, THE ^{40 Cal} ~~9MM~~ HANDGUN, MAGAZINE AND AMMUNITION WERE COLLECTED AND SUBMITTED INTO EVIDENCE.

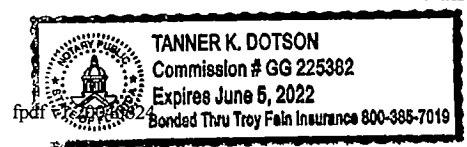
