DEFENDANT DID THE FOLLOWING ACT(S) WHICH CONSTITUTE A VIOLATION OF THE LAW (ELEMENTS OF THE CRIME / PROBABLE CAUSE STATEMENT)

On 02/17/20 at approximately 2252 hours, while employed by the Collier County Sheriff's Office as a Certified Law Enforcement Deputy, assigned to Golden Gate Estates road patrol, I was dispatched to the area of 1597 Mockingbird Dr in reference to a possible disturbance involving a gun and a knife. The initial 911 call was by rapid SOS coordinates and was coming back to the area of Mockingbird Dr, but did not a physical address. I canvassed the area and a ping was done on the initial caller's cell phone. At this time the ping came back with a hit in the nearby area of the wood line. Upon my arrival in the area, I canvassed the area, with negative results. An attempt to call the caller back was made. A female answered the phone, later identified as Sheila Walker (SW). Her voice was soft and she sounded like I just woke her up. I asked her if she was okay and she stated she was and admitted to calling 911 by accident and was on her way to Miami. At this time the phone disconnected and I was unable to make contact again. An updated ping was then done, showing the phone to have moved to another location off of Tobias St. I again canvassed the area, with negative results.

On 02/18/20 around 0116 hours I responded to NCH East located at 15420 Collier Blvd in reference to a female stating she was involved in a disturbance with a gun and knife. Upon my arrival with the caller, identified as SW, by FL DL. She had a laceration on her eye brow, which was bleeding and swollen. I could also smell the heavy odor of an alcoholic beverage emitting from her facial area. She stated that she came to Naples from Miami to meet up with an elderly male by the name of Josh, who she had met on an unknown "sugar daddy" website. She further stated that she convinced her friend, Stevens Joseph, to drive her to Naples, and drop her off at a residence located at1596 Mockingbird Dr. SW stated that she and Josh were inside of the home, talking about the hard times she was having. She stated that she had just returned from Law Vegas and was having trouble paying her rent, so Josh agreed to assist her and handed her \$400. The two then sat in the kitchen and began eating food, when Josh began to get angry that she was not "proving services." She asked him what he meant and he began to become aggressive and yelled at her. The two of them ended up in the bedroom, where Josh then pulled a black gun on her and pointed it at her demanding the money back. SW stated that she was able to get out of the bedroom and make it to the front door, however Josh was already there. He put down the gun down and picked up a knife and held it by her and again demanded \$200 back. At this time a struggle ensued and SW advised Josh that she had called the cops. While Josh was attempting to grab the phone from SW's hands he hit her in the face with his elbow, striking her in the eye brow. She did not give him permission to touch her or strike her against her will. After a short time, SW was able to get out of the house and ran down the street in fear, to meet her friend. SW denied EMS on scene.

SW stated that she did not have any information on Josh due to meeting online and just meeting him but described him as an elderly male approximately 5'09" with grey hair and blue eyes. She provided me with a video recording of John admitting to what had just occurred to her. SW stated she is more upset that he did not apologize and admitted to his actions and was arrogant about it. She stated that she knows Josh is a rich man and angry that he did not apologize, so wishes to press charges for aggravated assault at this time.

A welfare check was then conducted on the male, later identified as Joshua Lewin at his residence located at 1596 Mockingbird Dr. He was calm and cooperative and stated that he knew what SW has told us and he stated "I was robbed but going to wash my hands of this and didn't want to call you guys."

He further state that he met SW on the Naplesescorts.com website and invited her over "for a release." The two agreed on a price of \$400 for services but when SW became bossy and demanding and not preforming the services they

He then stated that she then tried to leave and in fear that she had someone waiting outside to come in and attack him, he placed the gun down and picked up a knife and again demanded the money back. At this time SW left the residence, and Josh stated he went to bed.

Det. Klonowski (ID #979) was notified and responded on scene. He took taped statements on scene from all parties involved and photographs of SW's injuries. After the interviews, I was notified by Det Klonowski that Josh was under arrest for aggravated assault x2 and battery. He was then handcuffed to the front, properly spaced and double locked, and transported to NCJ for booking.

A VINE form was competed on behalf of SW. She was notified via telephone of the arrest and wishes to be notified upon Josh's release from jail.

No further information at this time.
