Upon securing Troy, contact was once again made with Michael Aviles, Security at the library. Michael advised that on March 12, 2020, at approximately 1725 hours, he received a call from the library staff advising him that a white male subject, later identified as Troy Joseph McCorvey, was on one of the library computers watching pornography. Michael advised that, upon making contact with Troy, Michael observed pornographic images on the computer which Troy was utilizing. Michael also observed Troy to have his pants down and removed approximately a quarter of the way down from his waist, exposing his penis and testicles. Michael advised that Troy was actively masturbating. Michael stated that he ordered Troy to get up and leave the library, at which point Troy began to make his way towards the library elevators. Michael stated that he advised Troy that he could not leave through the elevators and that he (Troy) needed to follow him (Michael) down the stairs. Michael stated that Troy ignored his commands and continued into the elevator. Michael advised that he placed his (Michael) arm in-between the elevator doors in order to prevent the doors from closing, at which point Troy grabbed onto Michael's arm and attempted to pull Michael into the elevator. Michael advised that he (Michael) then yanked his (Michael) arm away from Troy and was able to free himself. Troy was able to close the elevator doors even after being ordered by security not to go down the elevator. Michael then once again made contact with Troy by the elevator, on the first floor of the library, and was able to escort Troy out of the library. Upon exiting the library. Troy then began to run towards the wooded area, at which point Law Enforcement arrived on scene.
