On 12/27/17 at approximately 2057 hours, I was dispatched to 129 Hammon Ave Apt. 4, Palm Beach, FL in reference to a domestic disturbance. Palm Beach Police Communications advised that the caller stated that she was hit, thrown to ground and that she had a cut on her hand. Palm Beach Police Communications also advised that the female was locked in a room and the male subject was inside the residence in another room.

Upon my arrival, I met with Jason Edward Blood (W/M DOB: 02/08/1969) who was walking out of 129 Hammon Ave. Blood immediately came up to me as I exited my vehicle and stated that there was no reason for me to be there and that everything was okay. Officer Rothenburg and Sergeant Rothrock both arrived on scene and went into the apartment to check on the other party as I spoke with Blood outside the residence. When I asked what had occurred tonight, Blood stated that he and his girlfriend, Laurie Hammond (W/F DOB: 11/25/1970), had recently returned home from having dinner at a restaurant. Blood stated that at the restaurant, Hammond became mad at him after he spoke to another woman, Blood also stated that she doesn't normally get mad about that, but they had both consumed alcohol, and he believed that may have affected Hammond's reaction.

Once at the residence, Blood stated that he realized he did not have his key to the residence as Hammond was opening the door, so he asked her for his set of keys. Blood then stated that Hammond refused to give him the keys, so he raised his voice and grabbed her hand in order to take the keys away from her. At this time, Blood stated that Hammond began to swing her arms in his direction, hitting him in the chest. Blood stated that he did not bite Hammond, and that she would possibly tell us that he did, it should be noted that I did not mention anything to Blood about him biting Hammond prior to his statement. Blood stated that Hammond proceeded to lock herself in the bedroom as he started to pack his clothes, planning to leave for the night. Blood stated that as he was packing, he heard Hammond calling 911, so he decided to stop packing and step outside to avoid police officers from coming into the house, and at that time he saw me arriving on scene. I detained blood in the rear of my vehicle pending further investigation.

I went into the residence and met with Hammond. Hammond stated that Blood had too many alcoholic beverages at dinner and was raising his voice at her about various things. Hammond stated that once they arrived at her residence she asked him to go somewhere else for the night, she stated that Blood yelled at her to give him keys to the residence, and she refused to give them to him. Hammond stated that she proceeded to open the door and walk into her residence. Hammond stated that as she was walking into her residence, Blood grabbed her left hand and proceeded to bite it until she let go of the keys. Hammond stated that Blood then proceeded to push her into the wall where she fell to the ground, she then stood up and ran into her bedroom where she locked herself inside and called 911. Hammond stated that she was in fear and called 911 because she would feel safer with officers present. I observed and took pictures of Hammond's left hand where there were teeth marks that had broken the skin, causing bleeding. The teeth marks were located on her hand, above her pinky finger, and appeared to be in a straight line, following the curvature of her hand. This led me to believe that the bite had been done by someone other than Hammond herself. Hammond refused medical treatment, and stated that she was not hurt due to the fall.

Blood was read his Miranda rights, and he advised me that he understood them. Post Miranda, I asked Blood if he wished to speak to me, Blood went on to stating the same things he told me once I arrived on scene. I advised Blood that due to the facts and circumstances that I found through my investigation, he was being placed under arrest for Battery on Hammond.
